"More than a Woman: Strengthening Women's Participation in Politics and Governance"

Brief Introduction About SEND Sierra Leone

SEND is a non-governmental organization dedicated to creating a Sierra Leone with respect for human rights, accountable governance, food and nutrition security, and equal opportunities for men and women to thrive. We liaise with communities, traditional authorities, government institutions, and partners to combine resources to develop innovative solutions to alleviate poverty and enhance quality self-reliance.

SEND Sierra Leone has adopted the global Sustainable Development Goals (SDGs) to guide national development planning and implementation with our strategic approach. The pursuit of economic equality and social equity are mainstreamed in the SDGs. Our government's commitment is to improve social services delivery, strengthen gender and social inclusion, and prioritize the education sector.

SEND Sierra Leone is an independent structure, a local NGO registered in Sierra Leone. Our portfolio includes gender and women's empowerment, community development, WaSH, health, education, climate adaptation, and nutrition/agriculture.

Intervention areas are in Kailahun, Kenema, Kono, Western Areas Urban, Rural districts, and the District of Bonthe.

Our vision is to see a Sierra Leone where people's rights and well-being are guaranteed. Our mission is to promote good governance, voice, accountably essential services, and equality for women and men in Sierra Leone.

1. Background of the Project

With support from Irish Aid, SEND-SL has been implementing the project "Promoting Women's Participation in Governance Project." During the annual implementation period (2017-2019), the project empowered women to achieve more gender equality in Sierra Leone. Its beneficiaries were empowered through training, exposure visits, campaign funds, resources mobilization strategies, gender education, and advocacy support to work collectively to increase their representation in politics and governance. The number of women who contested the 2018 elections increased and more women was subsequently elected as Councilors and MPs. History was made for the first time; an independent woman won an election as MP in Kailahun District, and in Kono District, the first-ever female MP was elected. Despite progress, women's share in decision-making remains low as fewer are represented in leadership positions in political parties, local councils, Government Departments, Agencies, and parliament. This created the platform for the 'More than A Woman, Project.

The "More than a Woman: Strengthening Women's Participation in Politics and Governance" project be evaluated and works to empower women in the Eastern Region of Sierra Leone to increase their participation in politics and governance. The project scales up lessons learned from the Promoting Women's

Participation in Governance Project and incorporates the EU Observation Mission Report recommendations on promoting women's participation in politics and governance using the SEND model Kailahun Women Governance Network. It also contributes to achieving SDGs Goals 5 and 16 and the Sierra Leone National Development Plan of 2019-2023(SLNDP).

The project works with target beneficiaries across the three districts in the Eastern Region of Sierra Leone (Kailahun, Kenema, and Kono).

Overall goal: Improved women participation in decision-making, politics and governance in Sierra Leone

Overall outcome: SEND's organizational and delivery capacity is enhanced and women's participation in politics, decision-making, and governance in the Eastern Region is strengthened.

Four **outputs** espoused for success includes:

- 1. Strengthened women's collective voice, knowledge, capacity on gender, and accountability in politics and governance at district and regional level.
- 2. Women are economically empowered through resource mobilization and utilization.
- **3.** Increased national level advocacy and networking on women's participation in decision-making, governance and politics.
- **4.** Enhanced capacity of SEND for effective and result-oriented program delivery

2. Objectives of the Evaluation

The objectives are to:

- Assess the degree to which the project has reached its goal, outcome, outputs, and activities according to the indicators stated in the project description,
- Guide SEND and Irish Aid in improving strategic focus and knowledge when supporting future interventions on women's participation in politics and governance in a broader perspective,
- Guide SEND and its partners in future projects involving national and local level authorities in the political realm.

3. Methodology of the evaluation

This evaluation will be based on a combination of:

- **Literature Review:** a desk study of available project data, other publications, reports, and documentation on gender and women empowerment.
- **Key Informant Interviews**: interviews with Irish Aid Staff, SEND-SL Staff, interviews with core districts and local stakeholders in the three project district locations, including MPs, Councilors, political party leaders and Female Parliamentarians from the target districts.
- Focus Group Discussions: with rural network executives and their members in selected communities in Kailahun, Kemena, and Kono districts.
- Questionnaire Survey: with VSLA groups, women groups, traditional leaders, and radio stations

The evaluation is for the More than a Woman Project: Strengthening Women's Participation in Politics and Governance" project (2019-2021 and will be conducted according the OECD/DAC criteria for evaluations.

4. Scope of work

The scope of this evaluation will comprise but not be limited to open questions along the OECD/DAC Evaluation criteria:

• An outline of activities and strategies SEND could incorporate in future programming and describe how they can be carried out.

The report should include the following chapters: an executive summary, description of the evaluation methodology, background information, chapters on findings, conclusions, and recommendations for the future. The findings should be supported and documented by pictures and film as required.

The final report will also include many annexes, including a list of people and organizations interviewed and their contacts, and reviewed documents.

The report will consist of max 30 pages, excluding annexes and pictures.

7. Expertise required

One regional/local expert with relevant higher education and experience in gender issues, community development, governance, and conduct evaluations following the OECD/DAC criteria (minimum five years of relevant experience).
